Robinson and Thomas Kirkpatrick the present Board of County Commisioners within and for the said County of Lane and their successors in office of the Second Part. Witnesseth: That the said party of the first part for and in consideration of the sum of one dollar to them in hand paid. The receipt whereof is hereby acknowledged and for the further consideration that Eugene City; Seat of Justice for said County of Lane has been located partly thereon, have bargained and sold and by these presents do bargain sell and set over and convey unto the said party of the second part and their successors in office, all of that tract or parcel of land embraced with in the South Half of the Original Plat of said Eugene City and generally known as Mulligans Donation to said County containing Forty acres be the same more or less. And bounded as follows to wit: Beginning at a point on the East line bounding the land of Elias Stewart at the most Southerly in angle in said Boundry line and running thence West one chain and eighty four and a half links; thence North 20 chains to a point on the South boundary line of the land claim of Eugene F. Skinner thence East with said last mentioned boundry line 20 chains; thence South 20 chains; thence West eighteen chains and fifteen and a half links to the place of beginning. It being a part of the East Half of section 31 in Township 17 South Range Three West of W.M.

To have and to hold the premises aforesaid with all and singular the hereditaments and appurtenances thereto belonging unto the said party of the Second part and their successors in office forever warranting and defending the title thereof against the lawful right title Claim or demands of all and every person or persons whatsoever.
